ORDINANCE NO. 38

**AN ORDINANCE AMENDING SECTION 7 OF ORDINANCE NO. 31
RELATING TO MONTHLY SERVICE CHARGES**

WHEREAS, Notice of a Public Hearing to consider Ordinance 38 at 6:45 P.M. on July 21, 1992 at Central Marin Sanitation Agency Meeting Room, 1301 Anderson Drive, San Rafael, California, was published three times in the Independent Journal and the Ross Valley Reporter, and posted in three (3) public places in the District as prescribed by law,

WHEREAS, on July 21, 1992 at the noticed time and place a Public Hearing was held to hear public comment on the \$17.00 monthly sewer service charge that was proposed by Ordinance No. 38,

WHEREAS, on August 4, 1992, at a regular board meeting of the Board of Directors of Sanitary District No. 1, the Board of Directors made a careful study of the financial condition of the District, and found it necessary to amend Ordinance 38 to propose a \$15.75 monthly sewer service charge rather than the \$17.00 monthly sewer service charge noticed.

THEREFORE, THE BOARD OF DIRECTORS OF SANITARY DISTRICT NO. 1 OF MARIN COUNTY DOES ORDAIN AS FOLLOWS:

SECTION 1. Section 7 of Ordinance No. 31 of that certain ordinance entitled "Ordinance 31, An Ordinance Establishing Sewer User Service Charges," adopted by the Board of Directors of Sanitary District No. 1 on June 28, 1978, is amended to read as follows:

SECTION 7. Monthly Service Charge. Beginning July 1, 1992, the sewer user service charge shall be \$15.75 per month per sewer user unit or such lesser amount as amended by the Board of Directors at a later date. Penalties for non-payment shall be assessed in the same amount and in the same manner as penalties on County ad valorem taxes.

SECTION 2. Except as hereinabove provided for the amendment of Section 7, all of the balance of said Ordinance No. 31 shall remain in full force and effect.


SECTION 3. All ordinances and parts of ordinances inconsistent herewith are hereby repealed.

SECTION 4. Upon adoption, this ordinance shall be entered in the minutes of the Board of Directors of Sanitary District No. 1 and shall be published once in the Marin Independent Journal and Ross Valley Reporter, newspapers of general circulation within the District.


