Meeting of Sanitary Board of Sanitary District
No. 1, Marin County, California, held at the Town Hall at San
Anselmo, California, on Wednesday, the 9th day of June, 1909,
at the hour of eight o'clock P. M.

Present: Commissioners Holmes, Fomesbeck, Hecker
and Manning.

Absent: Commissioner Dibblee.

President Holmes in the chair.

The reading of the minutes of the previous meeting
were, upon motion duly made, seconded and carried, dispensed
with.

It was regularly moved, seconded and carried that
the bills of W. P. Taylor for \$200.00, John Ferraro for \$40.00,
A. F. Purdy for \$26.75 and J. E. Manning for \$40.00 be ordered
paid.

Commissioner Manning introduced the following
Ordinance and moved its adoption, to-wit:

ORDER NO. 6

AMENDING SECTION 15 OF ORDER NO. 1.

The Sanitary Board of Sanitary District No. 1, Marin
County, California, do ordain as follows:

Section 1. Section 15 of Order No. 1, of the Sanitary
Board of Sanitary District No. 1, Marin County, California, is
hereby amended to read as follows:

All work shall be done in a prompt, thorough
and workmanlike manner, under the direction and control of the
Plumber to whom the permit is issued; and to the satisfaction
of the Plumbing Inspector.

The Plumbing Inspector shall not issue a
permit to any Plumber who has violated any of the regulations
of the said Sanitary Board, without the written consent of said
Board.

The Plumbing Inspector shall receive, as compensation for his services, the following fees:

For each connection with the sewer system, the sum of \$2.50.

For each certificate of inspection the sum of \$2.50.

Said fee shall be paid in advance by the Plumber upon the issuance of the permit by the Inspector to execute the work.

Section 2. This order shall take effect from and after the day of its passage.

Section 3. All orders, and parts of orders, in conflict herewith, are hereby repealed. X

The motion to adopt said Ordinance was seconded by Commissioner Hecker, and upon being put to a vote was adopted by the following vote:

Petition heretofore presented to this Board praying that certain outlying territory, specifically described in said petition, contiguous to the territory of Sanitary District No. 1, of Marin County be annexed to said Sanitary District No. 1, having been taken up and considered by this Board at the regular meeting of this Board held on the 9th. day of June 1909, which was the first regular meeting of this Board after the presentation of said petition, and this board having duly considered the same, and it duly appearing to this Board from the evidence presented and considered that said petition is signed by the owners representing more than one-half of the assessed valuation of such contiguous territory proposed to be annexed as shown by the last equalized assessment book of the County of Marin, in which Sanitary District No. 1 is situate, and that said petition designates specifically the boundaries of such contiguous territory proposed to be annexed and the assessed valuation thereof as shown

by said last equalized assessment book, and also states that such territory is not within the limits of any other Sanitary District, and that such territory be annexed to said Sanitary District No. 1, and it appearing to this Board that all proceedings heretofore taken in the matter of said petition have been had and taken in the manner provided by law.

NOW, THEREFORE, IT IS HEREBY ORDERED by this Board that said petition be, and the same is hereby, approved, and that such approval be entered upon the minutes of this Board and endorsed upon said petition, and that said petition be thereupon transmitted to and filed with the Board of Supervisors of the County of Marin, State of California.

Said preamble and resolution was presented by Mr. Manning and he moved its adoption. The motion to adopt was seconded by Mr. Hecker and upon being put to a vote was adopted by the following vote:
